THREE TRIPS WERE MADE TO TENNESSEE WITH APPROXIMATELY 90 PEOPLE IN ATTENDANCE. THE MAJORITY OF ATTENDEES WERE GRASSROOTS UFMF MEMBERS. SEVERAL STATE AND LOCAL ELECTED OFFICIALS ALSO ATTENDED ONE TRIP. EACH TRIP INVOLVED BRIEFINGS FROM TENNESSEE STATE OFFICIALS ABOUT THEIR TAX SYSTEM (NO STATE INCOME TAX), THE IMPACT OF THAT SYSTEM ON BUDGETS AND HOW THEIR SYSTEM AIDS THEM IN PROVIDING REAL-TIME FINANCIAL PICTURE OF THE STATE'S ECONOMY AND IMPACT ON THE PLANNED BUDGET.
